Entry Rules/General Information



Entry: Participants must submit an entry form along with the entry fee. The fee is \$18.00 per participant and includes an original 2008 Laker Idol t-shirt. Checks should be made payable to **Prior Lake Chamber**. Returned checks are subject to a service charge. Entry fees are non-refundable. Entries should be mailed in by July 15, 2008 to: **Laker Idol, Prior Lake Chamber, 4775 Dakota / P.O. Box 114, Prior Lake, MN 55372.**

Each division will be limited to the first 20 participants to register. Upon receipt of a signed entry form and fee, you will be confirmed by e-mail (or phone) as a participant in the contest.

Divisions: Participants will compete in one of three divisions. The Little Laker Idol Division is open to participants age 12 and under. The Teen Laker Division is open to participants ages 13 through 17. The Adult Laker Division is open to participants 18 and older. **Participants must provide documentation of age – driver's license; school ID, birth certificate at auditions in July.**

Eligibility: The contest is open to all amateur entertainers. Professionals (union musicians or those whose talent is a principle source of income) are not permitted to enter. Participants that have competed in the past are welcomed again. Laker Idol first place winners in each division can only compete once every 3 years in the same division (ex. 2007 Classic Laker Idol winner cannot compete again in the same division until 2010). Participants must use either the karaoke equipment provided by the Laker Idol Committee or sing a cappella. No guarantee that submitted CDs will work on equipment provided. No instruments allowed. Any CDs used must be submitted 48 hours prior to performance to Prior Lake Chamber (address above) and picked up at the end of the participant's division contest. The Laker Idol Committee is not responsible for lost or stolen CDs. Participant's music selections will be reviewed for age appropriate lyrics and background voices that could potentially interfere with the Judge's ability to hear the contestant. The Laker Idol Committee reserves the right to ask participants to select another song in the event their selection is deemed inappropriate for their age and/or their selection does not allow the judges to hear participant's vocals clearly.

Judging Criteria: Participants will be judged primarily on vocal and stage presence. Judging criteria and helpful suggestions for participants will be posted at www.priorlakechamber.com as of July 1, 2008.

Schedule/Location: The contest consists of three parts: Auditions will be held on Sunday, July 20 and 27 at T.J. Hooligans in Prior Lake, MN. Semi-finalists will be notified by e-mail (or phone) the Monday following auditions. Semifinals and finals will be held on Saturday, August 2 at the Entertainment Stage at Lakefront Park in Prior Lake, MN. No media presentations of performance will be allowed at any time.

Directly after the division's semi-finals on August 2, the judges will select 3 finalists to sing off for the division's title. The judges' decisions are final.

Awards: The following awards in addition to a certificate will be given in each division:

1st Place \$100.00 2nd Place \$ 75.00 3rd Place \$ 50.00

Each 1st place winner will receive a free photo shoot for a CD cover.

Monies will be distributed in "Chamber Bucks" that can be used at any Prior Lake Chamber business.
